TaxDetective makes it easy for you to lower your property tax. All you have to do is complete the two *fillable* forms on pages 2 and 3, sign and date them, and return them to us. We will do everything else for you.

Using TaxDetective is easy; just complete the two *fillable* forms on pages 2 and 3 and return them to us. We will do the rest and keep you informed during the process.

Frequently asked questions

Do you need a copy of my Notice of Valuation that I received from the Assessor? No, we already have that information. We only need your two forms. An exception is if you have had a recent appraisal of the property, please fax or email this to us.

May I appeal more than one property? Yes! It is best to ask us to appeal all of the real properties that you own. You may use one set of forms for all properties providing they are all in Arizona. For properties in Other states, visit <http://www.taxdetective.com/> and at the Home page, click on "**FOR OTHER STATES: Appeal Now!**"

May I appeal non-residential properties? Yes! We welcome all types of real properties.

What if I sell my property? If you sell your property at anytime during the Appeal process, please let us know as soon as possible.

Are there up-front fees? Generally no. Tax Detective's business is lowering property taxes.

May more than one Appeal be filed on a property? No. By returning these forms to us, you agree that TaxDetective will be your sole representative for the current tax year. TaxDetective has the discretion to appeal at both the county and state (County Board) levels.

May I appeal properties in other states? Yes! Please return to the Home Page and choose "For Other States: Appeal Now!"

Are there filing deadlines? Yes. There is only a 60 day "window of opportunity" in Arizona. The filing deadlines vary depending on the county in which your property is located. See <http://taxdetective.com/pdf/assessaz.pdf> for further information. Failure to return your completed forms before the County deadline may mean that we will not be able to file your appeal.

- Persons who own, control, or possess property valued by the County Assessor may each year designate an agent to act on their behalf on any matter relating to the review of the valuation and classification of the property before the Assessor or the County or State board of Equalization.
- This designation of an agent expires at the end of the calendar / valuation year.
- This form or a copy must accompany any petition, Taxpayer Notice of Claim, or response to a Notice of Proposed Correction filed with the Assessor or either Board of Equalization. The original form shall be provided for inspection by the agent on request of the County Assessor, either Board of Equalization, or the Department of Revenue.
- Notices issued by the Assessor or either Board of Equalization relating to the review of the valuation of that property shall be sent to the agent of record.
- A petition for Review of Real Property or Personal Property, a Notice of Proposed Correction, or a Taxpayer Notice of claim will not be accepted unless the Agency Authorization Form accompanying the petition is signed by the person who owns, controls, or possesses the property.
