TaxDetective makes it easy for you to lower your property tax. All you have to do is complete the two forms on pages 2 and 3, sign and date them, and return them to us. We will do everything else for you.

Using TaxDetective is easy; just complete the two forms on pages 2 and 3 and return them to us. We will do the rest and keep you informed during the process.

We recommend that you email all forms in PDF format to us. We cannot process forms in any other format than PDF.

Frequently asked questions

Do you need a copy of my Notice of Valuation that I received from the Assessor? Yes, it would be helpful if you could also send us a copy of the most recent Notice of Valuation and/or Property Tax Bill.

May I appeal more than one property? Yes! It is best to appeal all of the real properties you own. You may use one set of forms for all properties providing they are all in the same state. For properties in other states, please send a separate set of forms.

May I appeal non-residential properties? Yes! We welcome all types of real properties.

Are there up-front fees? Generally no. Tax Detective's business is lowering property taxes. After receiving your two completed forms, we will determine whether an up-front fee is necessary and if so, we will then contact you by email.

May I appeal properties in other states? Yes! Please return to the Home Page and choose another state.

Are there filing deadlines? Yes. The deadline may be shown on the paperwork that you received from the Assessor. When you return your two forms, it would be helpful if you could also send us a copy of the most recent Notice of Valuation and/or Property Tax Bill.
